HOW TO REGISTER:

- 1) Please complete and return the following forms:
 - a) KCE registration & release form
 - b) Alpine Valley registration form and medical card

Note: It is **ABSOLUTELY ESSENTIAL** that the information on these forms be 100% filled out and accurate.

- 2) Sign and Return ALL forms and checks to the Kenston Community Education (KCE) office located at Gardiner Center 9421 Bainbridge Rd., Chagrin Falls, OH 44023.
 - a) Mastercard, Visa, Discover are accepted (include the card number, expiration date and the cardholder's name on the registration/release form).
 - b) Make checks payable to the Kenston Community Education.

NOTE: REGISTRATIONS MAY NOT BE MADE BY PHONE.

- 3) Registrations will be accepted on a first-come first-serve basis. A minimum of 35 students need to be registered in order for the club to operate.
- 4) Registration deadline to receive free passes is **NOVEMBER 10, 2016**. After November 10th, a \$15 late fee will be assessed and registrations will be taken on a space available basis.

NO REFUNDS WILL BE GIVEN ONCE THE PROGRAM HAS BEGUN.

TRANSPORTATION:

- 1) Skiers **MUST** go home at school dismissal and return at 4:15 p.m. to the Intermediate School parking lot.
- 2) All buses will depart from the parking lot at 4:30 p.m. for Alpine Valley and return to the same school at 9:30 p.m.
- 3) Skiers must be picked-up or leave the school **PROMPTLY** at 9:30 p.m. Phones **ARE NOT** available, so please have rides arranged. It is better for the student to get into a warm waiting car than to stand out in the wind and wait!

BUS RULES AND REGULATIONS:

- 4) Each student will be assigned a bus and will ride that bus.
- 5) Reasonable talking is okay. Boisterous conduct, yelling, screaming, etc., will not be permitted. The driver must be able to devote full time to driving for the safety of passengers.
- 6) Some parents have offered to help supervise. Their instructions are to be followed.
- 7) Once the bus is in motion students are to remain seated. No changing seats, standing or other horseplay will be tolerated.
- 8) Keep the bus as clean as possible.
- 9) Misbehavior on the bus or at the ski area could result in removal from ski club.
- 10) No radios will be permitted on the bus.

SPECIAL NOTE:

BE AWARE OF THE TIME AT ALPINE VALLEY AND RETURN TO THE BUSES AT THE DESIGNATED TIME.

CANCELLATION POLICY:

Should the weather/forecast such as ice, windchill warnings, heavy snow be forecasted...ski club will be cancelled by **NOON** that day. It will be posted on Facebook, Twitter and a email blast will go out.

RECOMMENDATIONS:

Preferred ski clothing: Hats, gloves, long underwear, warm coat, turtleneck sweater, socks

(1 thin pair, 1 heavy pair), ski pants, and scarf (must be worn inside coat for safety reasons).

Packed dinner or money for food (optional)

Money for a locker (\$1 – optional – may share with a partner).

(During ski times, all belongings (shoes, etc.) should be locked in a locker.)
